- VII. Nancy Bishop, Deputy Attorney General for the Idaho Department of Juvenile Corrections
- Briefing on Juvenile Corrections' proposals for juvenile sex offender management and registration
 - ◆ Risk-based
 - ◆ Juvenile court to manage juvenile registration decisions
 - ◆ Determination to transition to adult registry based on risk
 - ◆ Be cautious of language; i.e. high risk to reoffend means high risk in the community
 - ◆ Ensure psychosexual evaluations meet the SOMB standards and reference the standards
 - ◆ SOMB and IDJC will work jointly to present juvenile registration proposal
 - ◆ Present to judiciary for feedback as well
 - ◆ Three levels: Registry, non-public registry, no registry

- Revise language
 - ◆ Change Dynamic and Protective Variables to Risk Reduction Variables
